#### 1. Term

In consideration for the Installation Services, the Client shall pay the Contractor a <u>50% deposit upon booking</u> <u>and 50% upon completion of the job</u>. The Contractor shall invoice the Client once upon booking [Invoice time frame]and again upon completion. Such invoices shall be due and payable upon the Client's receipt of the invoice.

# 4. Confidentiality

The Contractor shall not disclose to any third party any details regarding the Client's business, including, without limitation any information regarding any of the Client's customer information, business plans, or price points (the Confidential Information), (ii) make copies of any Confidential Information or any content based on the concepts contained within the Confidential Information for personal use or for distribution unless requested to do so by the Client, or (iii) use Confidential Information other than solely for the benefit

## 5. Indemnification

The Client agrees to indemnify, defend, and protect the Contractor from and against all lawsuits and costs of every kind pertaining to the Client's business including reasonable legal fees due to any act or failure to act by the Client based upon the Installation Services.



**PandaDoc tip** | An example of when this clause comes into play: in the event a third party sues the Consultant for the Client doing or deciding not to do something based on the Consultant's advice, then the Client will cover the costs to the Consultant in such an action.

#### 6. No Modification Unless in Writing

No modification of this Agreement shall be valid unless in writing and agreed upon by both Parties.

#### 7. Applicable Law

This Consulting Agreement and the interpretation of its terms shall be governed by and construed in accordance with the laws of the State of Florida and subject to the exclusive jurisdiction of the federal and state courts located in Palm Beach County, Florida.
